2022 SMALL BUSINESS AND EDUCATIONAL GRANT APPLICATION

Eligibility Requirements:

- Applicant must be a Montana woman who is a small business owner or is seeking a grant for educational use.
Applicants must be in business for one year prior to application deadline unless grant is being sought for educational use.
Grants are intended for projects NOT otherwise eligible for aid, and are not awarded for religious purposes, to veterans' or fraternal organizations, for use as general endowment, or for fundraising.
Grant request is intended for a project planned in 2022-2023.
Grant request is intended for a project not yet funded, nor purchased.
Grant project or education enrollment must be completed within six (6) months of receipt of funds.
Applicant must be available for a personal interview with the Bozeman BPW Grant Committee mid-September 2022. Interview may be conducted via video conference or phone.
Recipients must file a progress report within six months of receipt of funds.
Selected recipients are strongly encouraged to attend the Honors Event in Bozeman in October to receive the award.
Only completed applications will be considered for funding. Please limit the volume of paperwork to your completed application and resume in one single email to grants@bozemanbpw.org.
